



Applicant Agreement

February 2021

In order to submit your VSLO application for an elective, you must agree to the following:

- 1. Your access and use of the Visiting Student Learning Opportunities (VSLO) Program services, including the VSLO Application Service, is governed by the <u>AAMC Website Terms and Conditions</u> and the <u>AAMC Privacy Statement</u>, which you agreed to when you created an AAMC Account and which you continue to agree to by your access and use of the AAMC website.
- 2. You agree, for each application you submit, that:
 - The information submitted in connection with the application is, to the best of your knowledge, complete, accurate, not false or misleading, and, if presented as your own work (for example, a statement on why you want to do the elective), written by you;
 - You have reviewed the requirements for the elective to which you are applying, and your application meets those requirements;
 - You understand that the elective to which you are applying may be filled while your application is being processed and that all final placement determinations are made by host institutions;
 - You will not have graduated from your degree program at your home institution until after the elective end date;
 - You will monitor your application status and respond promptly to communications, including elective offers and resolving scheduling conflicts;
 - Your home institution may choose not to release your application if you are no longer eligible for the elective, such as due to illness, a leave of absence, or as otherwise determined by your home institution;
 - You understand that there are inherent risks to travel and that you are responsible for your own health and safety while participating in an elective, regardless of location;
 - You are responsible for knowing and complying with all student conduct codes, university and hospital policies, and laws and regulations that may apply to you while participating in the elective;
 - You understand that a host institution may postpone, cancel, or convert to online/virtual
 offering an elective due to health and safety concerns or any other concerns beyond
 the reasonable control of the host institution;
 - You understand that the AAMC does not provide application fee refunds for VSLO
- 3. You authorize the following regarding your personal information:
 - The AAMC may release your application information to your home institution and to any host institution to which you submit applications;





- The AAMC may collect, use, retain, and transfer your personal information as described in the <u>AAMC Privacy Statement</u>;
- Your home institution may release your medical school transcript and health records and
 other information about you as requested by the host institution to each host institution
 to which you apply for the sole purpose of considering your application(s) at the host
 institution:
- You agree to the transfer of your personal information to the AAMC in the United States, to host institutions (wherever located) that you select through your application(s), and to other third parties as stated in the AAMC Privacy Statement;
- You agree to the processing and storage of your personal information on servers located in the United States and in any country of a host institution to which you submit your application;
- You acknowledge that once your personal information is transferred to a host institution or AACOM (for DO students), your personal information will be handled in accordance with that organization's privacy policies;
- You acknowledge that if you wish to exercise any data protection or privacy right that
 you may have under any applicable law regarding your personal information, you may

- For DO students only You agree that the AAMC has your permission to release deidentified data about your application and elective activity (including the schools and
 specialties to which you apply and the outcomes of the applications) to the American
 Association of Colleges of Osteopathic Medicine (AACOM) for research and analysis
 activities conducted by and within AACOM.
